participate in the City of Fresno Parks, After School, Recreation and Community Services (PARCS) programming, events and associated activities, operations and/or functions in the City of Fresno, County of Fresno, and State of California, beginning on the date signed below and ending on the dates indicated above, the Undersigned hereby voluntarily releases, discharges, waives and relinquishes any and all actions for personal injury, property damage or wrongful death occurring to him/herself arising as a result of observing, participating and/or engaging in activities, operations and/or functions or any incidental thereto wherever or however the same may occur and for whatever period said activities of the program or event may continue, and the Undersigned does for themselves, their heirs, executors, administrators and assigns hereby release, waive, discharge and relinquish any action or causes of action, aforesaid, which may hereafter arise from their estate, and agrees that under no circumstances will they or their heirs executors, administrators and assigns prosecute, present any claim for personal injury, property damage or wrongful death against the City of Fresno or any of its officers, agents, servants, or employees for any of said causes of action, whether the same shall arise by the negligence of any said persons, or otherwise. It is the intention of the participant by this instrument, to have agreed to the assumption of the risk and to exempt and relieve the City of Fresno and/or any of its officers, agents, servants or employees from liability for personal injury, property damage, or wrongful death suffered by the undersigned caused by passive or active negligence. The Undersigned, themselves, their heirs, executors, administrators or assigns agree to hold harmless, indemnify and defend the City of Fresno, its officials, members, agents and employees against any claims, costs, damages, demands, liability and notices, or any of these, liability and notices, arising out of performance under this agreement regardless of whether the City of Fresno is actively negligent or passively negligent, except for those claims, costs, damages, demands, liability and notices, or any of these, caused solely by the negligence or willful misconduct of the City of Fresno.

Media Release: Additionally, the Undersigned voluntarily consents to use of the Participant's photograph, name, image and likeness (Recordings), and waives and releases City of Fresno from any and all claims, causes, damages, liabilities and/or actions arising there from and/or relating thereto, whatsoever, provided said use shall be for non-commercial purposes in connection with advertising, administrative, programmatic and promotional activities and materials.
